## **Executive Summary**

The Risk Management Division ("RMD") was established to meet critical needs for public entities in the State of New Mexico. *See* RMD's organic statute, NMSA 1978, §15-7-1 *et seq.* 

RMD is responsible for self-insured administration and procurement of insurance to protect the Public Liability Fund (*see* § 41-4-23), the Workers' Compensation Retention Fund (*see* § 15-7-6), and the Public Property Reserve Fund (*see* § 13-5-1). Section 51-1-15 charges RMD with administering the State Government Unemployment Compensation Reserve Fund and the Local Public Body Unemployment Compensation Reserve Fund. As part of this responsibility, RMD works to limit the cost of excess insurance, so agency risks are truly "self-insured" and rates relate more directly to actual losses incurred.

Separate units within RMD, known as Bureaus, carry out the division's diverse functions. The following narrative describes the operations of each individual RMD Bureau and accomplishments in 2024.

This report also includes Property and Casualty Liability claim numbers for calendar year 2024.

The Risk Management Division has struggled with escalating claim costs and changes to laws affecting Civil Rights awards. We are thoughtfully addressing these issues by examining State Agency loss trends and claim settlement amounts. We are evaluating our State Agency cost assessments and are considering changes to our agency premium base. We are also increasing loss prevention measures to further assist State agencies, and, utilizing our Alternative Dispute Resolution Bureau as effectively as possible.

We look forward to a productive, and dynamic, 2025.

#### Legal Bureau

The Legal Bureau provides executive strategic management over all civil cases covered by the liability fund that are in active litigation. Such litigation includes State and Federal Civil Rights Claims, Employment Claims, Medical Liability, Tort Claims, Inspection of Public Records Act Claims, and Ethics Commission Complaints involving great bodily harm, Child Abuse, and Wrongful Death.

The Legal Bureau supervises forty-four contracted civil defense firms located throughout the State. The Legal Bureau is responsible for all major decisions during litigation including trial tactics, motions and appellate practice, and final determinations on taking cases to trial or reaching settlement. The Legal Bureau provides specialized expertise in settlement negotiations and mediations with the aim of reaching the best possible settlement outcomes in cases determined to be appropriate for settlement.

In 2022, the Legal Bureau was proud to have managed the litigation team, while working closely with DOH, that finally resolved the Jackson et al., Consent Decree Case after 35 years. The strategies and analytics employed in that case are being used to develop new approaches and outside the box thinking to approach other high liability matters.

The Legal Bureau has implemented new performance standards for contract defense counsel and is spearheading the push to take defensible cases to trial, developing trial practice skills, and flagging the legal issues to challenge on appeal.

The Legal Bureau is an effective team of attorneys and law clerks with diverse backgrounds and skillsets. The Legal Bureau has been expanded. Additional attorneys, and a second Legal Bureau Manager, have been added. The Legal Bureau will be fully staffed going into 2025.

#### **Finance Bureau**

The Finance Bureau supports all Risk Management Divisions (RMD) by centralizing the Division's financial functions, providing accountability, and ensuring timely processing of financial transactions. The Bureau manages budget preparation, financial reporting, encumbrances, accounts receivable, accounts payable, and contract administration. The Bureau played an integral part in the FY24 transfer of the Employee Health Benefits bureau to the newly formed Health Care Authority.

The Finance Bureau also serves one of RMD's key functions – administering and tracking seven risk funds. Fund solvency has been an ongoing concern and continues to be for several RMD funds to include public liability. The bureau is responsible for managing legal, worker's compensation, alternative dispute resolution and property & casualty contracts and RFP's. The bureau manages the AR, AP and budget responsibilities for the division.

The Finance Bureau (Bureau) accomplishments for 2024 include being the primary contact and coordinator of the transition of the Employee Benefits Bureau to the newly established Health Care Authority (HCA) of the State of New Mexico. The Finance Bureau provided the FY25 budget to the HCA for the State Health Benefits submission. The Finance Bureau Chief transferred eleven contracts to the HCA to maintain health insurance coverage for all covered state and local public body employees and their dependents. The Finance Bureau issued two legal RFP's in FY24. The second RFP increased hourly rates for contract attorneys which was needed to attract and retain counsel. The bureau also posted a total of six RFP's in FY24 to include Worker's Compensation third party administrator (TPA) and pharmaceutical benefits manager, insurance broker, unemployment TPA and legal services. The bureau also contracted with several Alternative Dispute Resolution suppliers for training support. The Bureau continues to review and improve streamlining its processes and automating wherever possible.

#### Alternative Dispute Resolution and Loss Prevention Bureau

The Alternative Dispute Resolution (ADR)/Loss Prevention Bureau promotes and offers dispute resolution and loss prevention services to help agencies prevent

workplace conflict and workplace incidents. Historically, the goal of the bureau was to provide mediation to state employees, certify new mediators, provide training for veteran mediators, and offer various trainings to state employees.

In fiscal year (FY)24, the bureau laid the groundwork to expand its services to state agencies. Rebranding focused on who our customers were, state employees. By recognizing that the bureau is designed to support employees experiencing workplace issues ranging from one-on-one conflict, large group conflict, and challenges with workspace we recognized the need to provide intensive marketing and outreach.

Restorative practices have been key in bringing self-development and reflection to large team dynamics. By following up with additional training in a three or four-tier approach we hope to achieve a solid base for agencies. Trainings are now agency specific and designed based on agency need for services.

The bureau was mindful to keep the old structure while incorporating new programs and provided the following in FY24:

The ADR Bureau is the first line of defense to help mitigate workplace conflict. The goal of creating an environment where peers can work together on the overall missions of their agencies drives the need for the bureau to be flexible to the needs of the evolving workplace culture.

#### Workers' Compensation Management

RMD made changes to RMD's Worker's Compensation Bureau (WCB) in 2024. The bureau has been dissolved. All eligible workers compensation injuries are now being professionally handled by a Third-Party Administrator (TPA).

RMD's worker's compensation standards have not changed. We continue to fulfill RMD's statutory obligation to administer and monitor the Workers' Compensation Retention Fund and effect prompt and fair payment of workers compensation claims brought by state employees and employees of covered educational entities or local public bodies in accordance with the Workers Compensation Act, *see* NMSA 1978 §§ 51-1-1 *et seq.*, 15-7-6, and 52-1-3. WCB provides thorough and efficient claims administration of workers' compensation claims. WCB continues to contract services from case managers, investigators, and attorneys to meet the Workers' Compensation Act's statutory obligations, while also protecting the solvency of the Workers Compensation Retention Fund. The State is obligated to pay for all reasonable, necessary, and causally related medical care from alleged occupational injuries occurring during the course and scope of employment and provides an early return to work program that can reduce the average number of weeks a worker is absent because of an injury and can potentially increase employer savings. Modified work allows the workers to return to work with the same employer.

The WCA has its own administrative court to resolve disputed cases through its Adjudication Bureau. A complaint can be filed at any time for a variety of reasons and initiates the dispute resolution process. A mediation hearing is scheduled for all involved parties. Most worker's compensation disputes are resolved through mediation. Per statute, attorney's fees for both sides are capped at \$22,500.

## Property and Casualty Bureau (PAC)

The PAC Bureau has a professional team of New Mexico licensed adjusters responsible for claim administration while working directly with agencies, claimants, insurers, and attorneys. This work includes losses involving vehicular damage, property damage, general liability, auto liability and other high frequency claims not anticipated to involve prolonged litigation. The PAC Bureau is tasked with evaluating and adjusting such claims and making liability and property payments in accordance with the Letter of Administration, coverage documents and the Tort Claims Act, NMSA 1978, § 41-4-1 through 41-4-30.

In addition to liability payments, the PAC Bureau is also responsible for administering claims against the Public Property Reserve Fund, which protects "public buildings" of state agencies against loss or damage from fire, windstorm, hail, smoke, explosion, riot, flood, or civil commotion as required by § 13-5-1. Section 13-1-5(B).

# Statutory Claim Payment Disclosure

Each year, RMD discloses indemnity payments over \$1,000.00 issued from the Public Liability Fund in its Annual Report per NMSA §15-7-3 (C). Since this report is a public document, RMD must comply with the confidentiality provisions of NMSA § 15-7-9 when disclosing claims payments data. This statute protects fund solvency while still allowing for transparent reporting of the use of taxpayer dollars.

Under NMSA §15-7-9, information about a claim may be released after a statutorily specified date of disclosure on and after:

- (a) the date a final judgment is issued resolving the claim and all appeals and rights to appeal have been exhausted; or
- (b) the date a settlement agreement is signed by all the parties.

In compiling this disclosure, RMD completed a thorough database search of all claims paid in Fiscal Year 2024 in accordance with NMSA §§ 15-7-9(A)(2)(c) and 15-7-9(A)(2)(d).
