Executive Summary

The Risk Management Division (“RMD”) was established to meet critical needs for public entities in the State of New Mexico. *See* RMD’s organic statute, NMSA 1978, §15-7-1 *et seq.*

RMD is responsible for self-insured administration and procurement of insurance to protect the Public Liability Fund (*see* § 41-4-23), the Workers’ Compensation Retention Fund (*see* § 15-7-6), and the Public Property Reserve Fund (*see* § 13-5-1). Section 51-1-15 charges RMD with administering the State Government Unemployment Compensation Reserve Fund and the Local Public Body Unemployment Compensation Reserve Fund. As part of this responsibility, RMD works to limit the cost of excess insurance, so agency risks are truly “self-insured” and rates relate more directly to actual losses incurred.

Separate units within RMD, known as Bureaus, carry out the division’s diverse functions. The following narrative describes the operations of each individual RMD Bureau and accomplishments in 2025.

This report also includes Property and Casualty Liability claim numbers for calendar year 2025.

The Risk Management Division has struggled with escalating claim costs and changes to laws affecting Civil Rights awards. We are thoughtfully addressing these issues by examining State Agency loss trends and claim settlement amounts. We are evaluating our State Agency cost assessments and are considering changes to our agency premium base. We are also increasing loss prevention measures to further assist State agencies, and utilizing our Office of Mitigation, Prevention & Resolution Bureau as effectively as possible.

Legal Bureau

The Legal Bureau provides executive strategic management over all civil cases covered by the public liability fund. Such litigation includes State and Federal Civil Rights Claims, Employment Claims, Medical Liability, Tort Claims, Inspection of Public Records Act Claims, and Ethics Commission Complaints involving great bodily harm, Child Abuse, and Wrongful Death.

The Legal Bureau supervises forty-seven contracted civil defense firms located throughout the State. The Legal Bureau is responsible for all major decisions during litigation including trial tactics, motions and appellate practice, and final determinations on taking cases to trial or reaching settlement. The Legal Bureau provides specialized expertise in settlement negotiations and mediations with the aim of reaching the best possible settlement outcomes in cases determined to be appropriate for settlement.

In 2025, the Legal Bureau increased in size from four in-house attorneys to eight. This change has reduced individual attorney claim load and allowed for more RMD participation in litigated claims.

The Legal Bureau has implemented new performance standards for contract defense counsel and is spearheading the push to take defensible cases to trial, developing trial practice skills, and flagging the legal issues to challenge on appeal.

The Legal Bureau is an effective team of attorneys and law clerks with diverse backgrounds and skillsets.

Finance Bureau

The Finance Bureau supports all Risk Management Divisions (RMD) by centralizing the Division's financial functions, providing accountability, and ensuring timely processing of financial transactions. The Bureau manages budget preparation, financial reporting, encumbrances, accounts receivable, accounts payable, and contract administration. The Bureau played an integral part in the FY25 execution of \$146,896,905 in payments made to outside vendors as related to claims management

The Finance Bureau also serves one of RMD's key functions – administering and tracking seven risk funds. Fund solvency has been an ongoing concern and continues to be for several RMD funds to include the public liability fund. The bureau is responsible for managing legal, worker's compensation, office of mitigation, prevention & resolution (OMPR) and property & casualty (PAC) contracts and Request For Proposal's for all bureaus. The bureau manages the Accounts Receivable, Accounts Payable and budget responsibilities for the division.

The Finance Bureau accomplishments for FY25 include re-issuing a new legal RFP to attract new law firms and increase hourly rates for contract attorneys. The bureau also contracted with several new OMPR suppliers for training support. The Bureau continues to review and improve streamlining its processes and automating wherever possible.

Office of Mitigation, Prevention & Resolution

The Office of Mitigation, Prevention & Resolution Bureau is an evolving bureau designed to introduce agencies to new strategies on how to navigate internal workplace issues ranging from workplace conflict to workplace incidents. The newly developed bureau offers services that are designed to provide preventative concepts across the board that help administrators, supervisors, managers and employees in mitigating issues at the very lowest level.

Fiscal year 2025 was pivotal for OMPR as it launched new direct services to agencies and developed relationships with those agencies. The expansion of services included a redesigned mediation program, addition of restorative practices (designed for large groups), safety guidance and trainings. Each of these services include aftercare and training for ongoing restoration.

By providing these new services it was important that other areas of the state receive these services. Historically, Santa Fe and Albuquerque were the primary recipients due to the proximity and resources available. However, in FY25 OMPR provided a variety of services in Alamogordo, Clovis, Espanola, Farmington, Gallup, Las Cruces, Los Lunas, Raton, Roswell, Taos and soon T or C. The importance of flooding services across the state is to develop a base where all corners of the state have a proactive opportunity to mitigate and help employees in many areas of their workplace.

In FY25 OMPR built the infrastructure by:

- Revamping the bureau
- Training facilitators in restorative practices
- Expanding mediation services
- Bringing all our agency coordinators (ADR & loss prevention), mediators, facilitators together for quarterly meetings
- Talking with and developing relationships with human resource professionals

- Hiring new contractors
- Doubling staff that are strategically assigned to regions of the state to provide support
- Tailoring and developing new training for agencies

It was not an easy task. This came with change that was uncomfortable. However, agencies began to recognize that our goal was not punitive but preventative. Conversations were no longer difficult but engaging as agencies knew we were here to support and the understanding that support comes with constant adjustments to meet agencies where they are at. By collaborating with agencies, they are open to new ideas and approaches.

Workers' Compensation Program

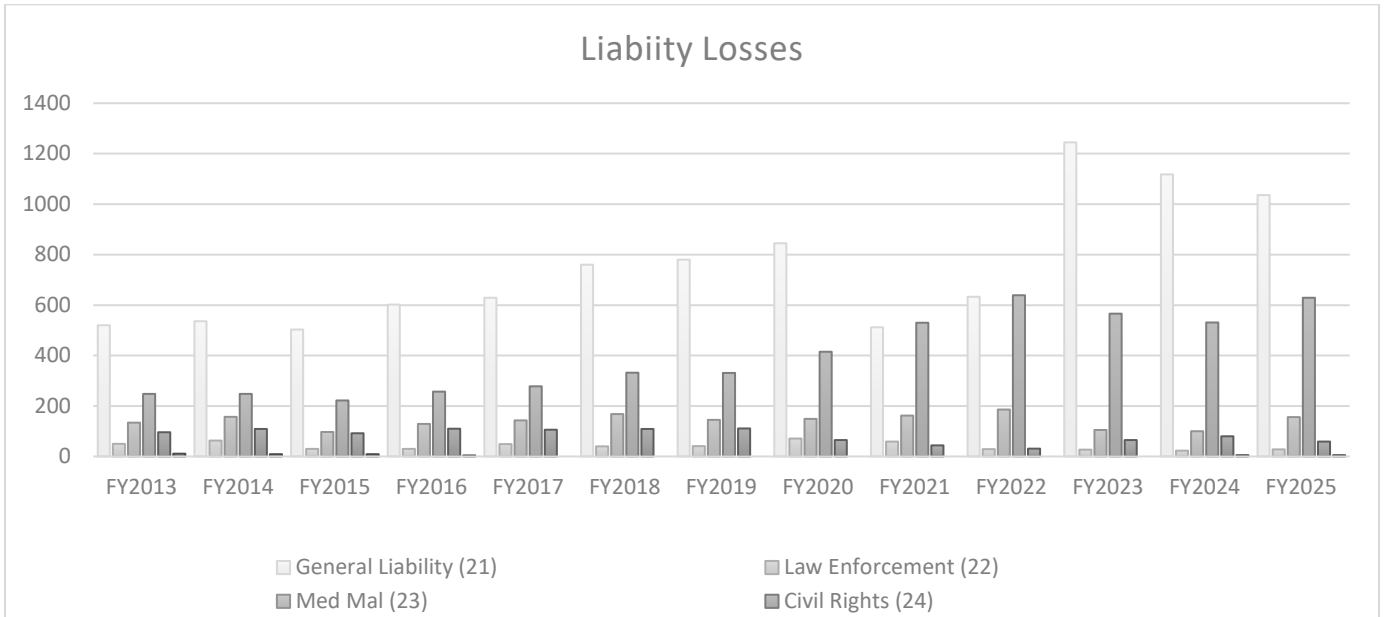
RMD made changes to RMD's Worker's Compensation Bureau (WCB) in 2024. The bureau has been dissolved. All eligible workers' compensation injuries are now being professionally handled by a Third-Party Administrator (TPA).

RMD's workers' compensation standards have not changed. We continue to fulfill RMD's statutory obligation to administer and monitor the Workers' Compensation Retention Fund and effect prompt and fair payment of workers compensation claims brought by state employees and employees of covered educational entities or local public bodies in accordance with the Workers Compensation Act, *see* NMSA 1978 §§ 51-1-1 *et seq.*, 15-7-6, and 52-1-3. WCB provides thorough and efficient claims administration of workers' compensation claims. WCB continues to meet the Workers' Compensation Act's statutory obligations, while also protecting the solvency of the Workers Compensation Retention Fund.

In the 2025 Legislative Session, HB66 was signed into law which increases the amount of money that can be advanced by employers for discovery costs and increases the maximum amount of attorney fees that can be collected in a workers' compensation or occupational disease disablement case. The cap on attorney fees including paralegal services, legal clerk services and any other related legal service costs is \$30,000 in calendar year 2025. Beginning January 1, 2027, the maximum allowable attorney fees will be capped at \$32,000 and beginning January 1, 2029, the maximum allowable attorney fees will be capped at \$34,000. The law also caps bad faith claims at \$5,000.

Property and Casualty Bureau (PAC)

The Property and Casualty (PAC) Bureau is responsible for underwriting and claims for the overall success and implementation of the state's insurance needs with proper coverage placement and claims administration providing multi-line insurance coverage that protects and conserves the state's physical and human resources. We provide service and assistance to our state agencies, local public bodies, higher education, boards and commissions, and various other NM state entities located across the Land of Enchantment.



Statutory Claim Payment Disclosure

Each year, RMD discloses indemnity payments over \$1,000.00 issued from the Public Liability Fund in its Annual Report per NMSA §15-7-3 (C). Since this report is a public document, RMD must comply with the confidentiality provisions of NMSA § 15-7-9 when disclosing claims payments data. This statute protects fund solvency while still allowing transparent reporting of the use of taxpayer dollars.

Under NMSA §15-7-9, information about a claim may be released after a statutorily specified date of disclosure on and after:

- (a) the date a final judgment is issued resolving the claim and all appeals and rights to appeal have been exhausted; or
- (b) the date a settlement agreement is signed by all the parties.

In compiling this disclosure, RMD completed a thorough database search of all claims paid in Fiscal Year 2024 in accordance with NMSA §§ 15-7-9(A)(2)(c) and 15-7-9(A)(2)(d).
